Following the qualification of SOLABS QM10 release 10.9.1:

- An issue was found in the Training section when a Questionmark assessment is linked to a training activity. It may happen that when the assessment is completed in Questionmark and when returning back to SOLABS QM10, the **Record my Training** option is not present as it should be. The only option available is Open Assessment and the user needs to redo the assessment even if completed successfully. This issue has been fixed under QMX-1629.
- An issue has been found when modifying a document if the document type is modified and if the new selected document type has an auto generated control number. In that case, if the document that is modified has an Approved & Effective Status, when the new document type selected has an auto generated control number, it will take the control number of the last created document of that type. Thus, this causes to have more than one document with the same auto generated control number. This has been fixed under QMX-1506.
- It has been reported that it would be easier to view the Job Title(s) assigned to a user in the Employee Training Compliance SSRS Report directly and not have to go to another report to get that information. This has been implemented under QMX-1509.

The corrective release 10.9.1-2 has then been issued for the qualification of these 3 issues/changes and was tested using the following tests:

- Test SOLABS\_QMX\_1506
- Test SOLABS\_QMX\_1509
- Test SOLABS QMX 1629

#### **Testing Results:**

- Test SOLABS\_QMX\_1506 was executed <u>successfully</u>
- Test SOLABS\_QMX\_1509 was executed <u>successfully</u>
- Test SOLABS\_QMX\_1629 was executed <u>successfully</u>

There was no deviation generated during the testing of the corrective release 10.9.1-2.

The three tests have been executed with a successful result which confirms that the issues and the new feature have been successfully corrected and implemented.

This memo confirms that SOLABS **QM 10.9.1-2** corrective release is qualified for use in a production instance and can be installed wherever the SOLABS QM 10.9.1 (or 10.9.1-1) is installed.
