Re: Release Memo for SOLABS QM 10.9.1-1 (Corrective Release)

Following the qualification of SOLABS QM10 release 10.9.1:

- The Office365 connector (used by QM10 for the Collaborative Review) has been updated to use MSAL instead of ADAL, which is to be retired in December 2022. This needed to be implemented before that date (QMX-1034).
- An issue was found in the Task section where modifying a task or a task group can move this task or task group (location changed) if the Location set is not in the last 25 created task groups (as it is not part of the Location field list). It was decided to fix that issue (QMX-1498) and include additional issues present in the task section (QMX-1236, QMX-1383, QMX-1441 and QMX-1500).
- When a corrective release is deployed, the Graphical User Interface footer displaying the release number is not updated with that number as when a minor or major release is done. This has been fixed.

The corrective release 10.9.1-1 has then been issued for the qualification of these 3 issues and was tested using the following tests:

- Test SOLABS_QMX_1034
- Test SOLABS_QMX_1236_1383_1441_1498_1500
- Test SOLABS_QMX_1489

Testing Results:

- Test SOLABS_QMX_1034 was executed successfully
- Test SOLABS_QMX_1236_1383_1441_1498_1500 was executed successfully
- Test SOLABS_QMX_1489 was executed <u>successfully</u>

There was no deviation generated during the testing of the corrective release 10.9.1-1.

During testing, two (2) issues were found in the Task section:

When a Task Group created under a parent task group is modified and does not have the same Reference Date as the parent, the reference date is updated by default to the one set on the parent Task Group on the Modify action (even if this field is not updated manually). It must remain set to the Reference date set on the current Task Group.

If a task that has a status set to Completed is modified and the status is changed from Completed to In Progress and changed back to Completed in the same modify (or Act On) action, this makes the page crash when submitting the action.

Both of these issues have been fixed and retested with a successful result after a second update.

This memo confirms that SOLABS QM 10.9.1-1 is qualified for use in a production instance and can be installed wherever the SOLABS QM 10.9.1 is installed.
